tablished in Resolution No. 50 of the Municipal Council of  
Ormoc for the November Election in 1947 be modified in so far  
as precincts Nos. 2, 20, 28, and 31 are concerned by transferring  
the respective seats of election precincts to the barrios as  
above stated so as to conform to the mandatory provisions of  
the Election Law in the establishment of election precincts.
