RESOLUTION NO. 126

In justice to the electors of Bar. Hibunawon in precinct No. 48 and in compliance with the mandatory provision of the Revised Election Law on the proportionate distribution of voters and in order to give the electors of Hibunawon facility to vote to the nearest polling place and in compliance with the requirement of the Law that precinct shall comprise as far as practicable contiguous and compact territory,

The Board, on motion of Councilor Margarito G. Tugonon, seconded by Councilor Antonio C. Cataag.

RESOLVED, as it is hereby resolved that the electors of barrio Hibunawon in Precinct No. 38 be transferred to Precinct No. 43 at barrio Dolores;

RESOLVED FURTHER, to send certified copy of the Resolution to the Hon. Commission on Election, Manila; to the Hon. Secretary of the Interior, Manila; to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; and to the City Auditor, Ormoc City for their information guidance and corresponding action of the authority concerned.

Councilors Margarito G. Tugonon, Pablo S. Pajaron, Flaviano Montesclaros and Antonio C. Cataag voted in favor of the Resolution.

Councilor Guillermo T. Parrilla, Rafael D. Omega, Victorino C. Teleron and Cleto P. Evangelista voted against.

The Chair announced to submit the votation to the Ruling of the Hon. Secretary of the Interior and Hon. Commission on Election, Respectively, the result of the votation which is a deadlock.
