RESOLUTION NO. 132

Letter of Conrado S. Sabelino, President P.T.A. Ormoc District I dated August 27, 1949 requesting the Honorable members of the Board to reallocate funds set aside for classrooms rental to purchase sawali for temporary wall of the unfinished Home Economics Building.

The petition is based on the fact that many classes have been transferred to the partly finished school building. Whatever allotment which may have been set aside for the rentals of private houses previously used for classroom purposes is now free for conversion to other needs.

That at present the Home Economics Building is not yet finished for lack of funds. During this rainy season the school children and the school equipments are wet due to the absence of sufficient siding to ward-off the rain. To meet this pressing need the parents and the teachers had to appeal to the Honorable Body for assistance.

It is appealed for the welfare of our school children for the immediate and favorable attention of the Municipal Board.

The Board, on motion of Councilor Victorino C. Teleron, seconded by Councilor Pablo S. Pajaron,

RESOLVED, as it is hereby resolved, that the amount of P400.00 be set aside to purchase sawali and other materials for the construction of temporary wall of the unfinished Home Economics Building of the Ormoc Elementary School this City as petitioned by Mr. Conrado S. Sabelino, President of P.T.A. Ormoc District I;

RESOLVED FURTHER, to authorize the City Treasurer, Ormoc City to revert the amount of P400.00 above stated from the unexpended balance of the original rental for private houses used for classroom purposes;

RESOLVED FURTHERMORE, to authorize, the City Engineer Ormoc City to estimate the expenses of labor and materials of the project above stated requesting said Department to accomplish the construction so as to meet the pressing need; and

RESOLVED FINALLY, to send a copy each to the Hon.
