WHEREAS, it has been observed finally that all the teachers of Ormoc District I especially the teachers of District II in barrio Valencia, Ormoc City come down to the City proper to get their monthly salary from the office of the City Treasurer, at the City Hall, therefore;

BE IT RESOLVED, as it is hereby resolved to respectfully request the City Treasurer, Ormoc City that the public school teachers of Ormoc District II at barrio Valencia, Ormoc City be paid their monthly salary on time at Valencia, Intermediate School, Ormoc City;

BE IT RESOLVED FURTHER, to respectfully request the City Treasurer, Ormoc City that the teachers of Ormoc District I, be paid their monthly salary at the City Elementary School, Ormoc City; and

BE IT RESOLVED FINALLY, to furnish copy of this resolution each to the Director of Public Schools, Manila; to the Division Superintendent of Schools, Tacloban, Leyte;
