BE IT RESOLVED FURTHER, that the unappropriated balance of Fifty Two Thousand Seven Hundred and Twenty Eight Pesos and Twenty Four Centavos (P52,728.24) be added to the General Fund estimated income as above provided, making a total estimated income of Three Hundred Thirty One Thousand Nine Hundred Seventy Seven Pesos and Twenty Four Centavos (P331,977.24) as basis for the appropriation of the Government of Ormoc City to be included in the budget for the fiscal year from July 1, 1949 to June 30, 1950.
