RESOLUTION NO. 16

The Board, on motion of Councillor Guillermo T. Parrilla, seconded by Councillor Victorino C. Teleron,

BE IT RESOLVED, as it is hereby resolved, that in compliance with telegram received by the City Mayor, Ormoc City, His Honor, Lucilo A. Conui, the seats of election precincts of precincts Nos. two, twenty, twenty eight and thirty one, Macabug, sitio Batuan, barrio San Juan, and sitio Picoy, respectively, be transferred to their former respective seats of precinct at barrio San Antonio, barrio Alegria, barrio Margen and barrio Sabang-Bao, respectively;

RESOLVED FURTHER, that in compliance with said telegram of the Honorable Commission on Election, Manila, precinct No. 51 be established as additional new precinct at sitio Picoy and its surrounding sitios with its seat of precinct at sitio Picoy;

RESOLVED FUTHERMORE, that all registered voters of barrio Sabang-Bao who are residents of sitio Picoy and its surrounding sitios within the newly established precinct No. 51 be transferred or registered at said precinct No. 51 at sitio Picoy the seat of precinct.

RESOLVED FINALLY to wire immediately the Honorable Commission on Election the compliance of its order and to furnish a copy of this resolution each to the Honorable Commission on Election, Manila; to the Honorable Secretary of the Interior, Manila; to the Division Superintendent of Schools, Tacloban, Leyte; to the City Mayor, Ormoc City, to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City and District Supervisor, Ormoc District II, Valencia, Ormoc City.
