RESOLUTION NO. 121

The Board, on motion of Councilor Rafael D. Omega,
seconded by Councilor Flaviano Montesclaros,

BE IT RESOLVED, as it is hereby resolved to authorize the Rehabilitation Finance Corporation, Manila to insure with the Government Service Insurance System the standard market building, 44-bays of 4 m. x 8 m, Ormoc City in the amount of Sixty Five thousand pesos (P65,000.00) covered by City loan from the RFC to be made effective October 3, 1949, as requested.

RESOLVED FURTHER, that the term of the insurance shall be for five (5) years;

RESOLVED FURTHERMORE, that the application for Insurance (Treasury Form No. 27-revised) be sent directly to the G.S. I.S. Manila, thru, the Treasurer of the Philippines in accordance with circular No. 30 A. (revised) of the Treasurer of the Philippines dated July 26, 1946 requesting the City Engineer, Ormoc City to examine and certify to the accuracy of the statements contained in the application with sketch of the location of the building stating the distances of the building to be insured from adjacent buildings, and the materials with which the roofs of the latter are made showing its surrounding within a radius of 20 meters.

RESOLVED FINALLY, to furnish a copy of this resolution each to the Hon. Secretary of the Interior, Manila, to the Rehabilitation Finance Corporation, Manila; to the Treasurer of the Philippines, Manila, to the Government Service Insurance System Manila; to the Hon. Secretary of Finance, Manila to the Director of Public Works, Manila; to the City Mayor; Ormoc City; to the City Engineer, Ormoc City; to the City Treasurer, Ormoc City and the City Auditor, Ormoc City.
