BE IT RESOLVED, as it is hereby resolved, to respectfully  
inform the construction Engineer of the Ormoc Market Tiendas  
Engineer Segura that the construction of the market afore-  
mentioned be continued in accordance with the plan and  
specifications and concessions as finally agreed by and  
between the Municipal Board, Ormoc City and said construc-  
tion Engineer, Segura as per Resolution No. 120 G.S. of the  
Municipal Board, this City, dated July 19, 1949.

RESOLVED FURTHER, to respectfully inform said construc-  
tion Engineer, Gregorio G. Segura that in connection with  
his letter addressed to the Honorable City Mayor, Ormoc  
City, thru the City Engineer, Ormoc City dated November  
19th, 1949, his request for modification of the contract  
finally agreed as above stated, of putting external  
knee bracing or diagonal bracing instead of longitudinal  
partition, as well as crosswise partition is hereby denied  
by the Board, and the determination of its advisability as  
suggested shall be considered by the Municipal Board after  
the construction of said Market shall have been completed and  
accepted;

RESOLVED FURTHERMORE, to respectfully inform the afore-  
mentioned Construction Engineer, Mr. Gregorio G. Segura that  
his request for partial acceptance of the market building  
completed in accordance with plans, specification and con-  
cessions as finally agreed by resolution of the Board above  
mentioned is hereby accepted;

Secretary of Finance, Manila; to the City Mayor, Ormoc

Gregorio G. Segura, Cebu City; and the Foreman in Charge  
of Construction, Ormoc City
