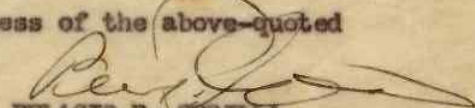
NOT THEREFORE, on motion of Councilor Antonio C. Cataag, seconded by Councilor Rafael D. Omega,

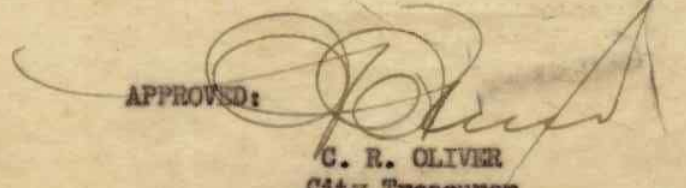
