RESOLUTION NO. 161

The Board, on motion of Councilor Rafael D. Omega, seconded by Councilor Flaviano Montesclaros,

BE IT RESOLVED, as it is hereby resolved, to authorize Councilors Margarito G. Tugonon and Antonio C. Cataag, this City to go to Manila to officially confer with the Hon. the Secretary of Interior and the Hon. the Secretary of Finance, Manila, respectively, for the purpose of expediting the approval of the City Budget and plantilla of personnel embodied in appropriation ordinance No. 2 for the fiscal year ending June 30, 1949-1950 of Ormoc City as unanimously approved by Resolution No. 160 of the Municipal Board, Ormoc City;

BE IT RESOLVED FURTHER, to authorize the aforementioned Councilors to confer with the different Department of the National Government, Manila for the purpose of expediting the approval of all new appointments of the City employees of Ormoc City which are still pending approval by the different departments and Bureaus, Manila; to confer with Honorable Congressman Domingo Veloso and Senate President Guenco on the resolution of the Municipal Board, this City requesting the Hon. Secretary of Justice, Manila to create a permanent sala of the Court of First Instance of Ormoc City; to confer further with said congressman on the amendments to the Charter of Ormoc City; and lastly to make official representation on vital problems affecting the City government of Ormoc;

RESOLVED FURTHERMORE, that the amount of P600.00 be appropriated from the City funds, not otherwise appropriated, to defray the traveling expenses of the councilors aforementioned for their official trip back and forth to Manila including their stay in the metropolis at P300.00 to each councilor respectively, with a view to fully accomplish their official purpose; and lastly requesting the secretary to the Board Ormoc City to wire the Hon. Secretary of Interior Manila requesting authority on the official trip of the Councilors concerned;

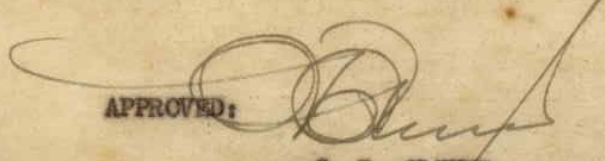
