RESOLUTION NO. 163

The Board, on motion of Councilor Rafael D. Omega, seconded
by Councilor Flaviano Montesclaros,

BE IT RESOLVED, that the amount of P9,856.00 which accrued
as aid to the Road and Bridge Fund, per letter addressed to the
Municipal Board by the City Engineer this City dated October 28,
1949 under 1st endorsement of the City Treasurer, this City dated
December 7, 1949, be approved;

RESOLVED FURTHER, that Projects Nos. J-27-6 and J-27-7, main-
tenance and repairs of City Streets, Ormoc City in the sum of
P3,000.00 and P4,000.00 respectively, or a total of P7,000.00
be expended to complete the asphaltting of Osmeña Street, portion
of Rizal Street from Solider Street, to connect with Real Street,
Poblacion.

RESOLVED FURTHER MORE, that Project No. J-27-8, maintenance
and repairs of City culverts and bridges in the amount of P2856.00
part only be expended to cement ditches or canals along business
streets specifically along Rizal and Real Street;

RESOLVED FINALLY, that the remaining amount of P2,856.00
of Project J-27-8 be expended to clean and improve streets
canals or ditches in the lower section of the poblacion,
specifically along Lopez Jaena Street, San Vicente Street,
and Osmeña Street giving particular attention to the repair
of old culverts and placing new ones to avoid clogging and
interruption of the flow of water on said ditches or canal.

Let copy of this resolution be furnished each to the City
Mayor, this City; the City Engineer, this City; and the City
Auditor, this City.
