Gentlemen:

Per verification of Appropriation Ordinance No. 2, current series, of that body, appropriating funds for the necessary expenses of the City Government for fiscal year ending June 30, 1950, we have found, among other things, that the unappropriated balance for Ormoc City District II, School, is P27,044.92 but the correct amount per record of this office is only P22,443.83. The amount available for appropriation, therefore, is only P61,540.84 instead of P66,141.93. The Total appropriations for Ormoc II is P65,501.38. This will result in a deficit of P3,960.54. We have also found that the estimate of taxes on agricultural products (around P5,190.87 as received last fiscal year) was included in the estimate of revenue for Ormoc District I. In order that the provable deficit in Ormoc District II may not be incurred the estimate of revenue under item "Taxes on Agricultural Products" for Ormoc II be increased to P10,381.74.
