RESOLUTION NO. 2

The Board, on joint motion sponsored by Councilors,
Margarito G. Tugonon and Rafael D. Omega, duly seconded
by Councilor Flaviano Montesclaros;

BE IT RESOLVED, as it is hereby resolved, to res-
pectfully request the City Treasurer, Ormoc City to
explain why, basing upon the trial balance of said Office
corresponding to December 31, 1948, the collection on
taxes for taxable real properties from June 1st to Decem-
ber 31, 1948 amounted to P10,174.70, while in the year
1949 covering the same periods only P7,448.71 were collected;


BE IT RESOLVED FURTHER to respectfully request the
City Treasurer, Ormoc City to submit a written explanation
to the Municipal Board why his office failed to furnish
the Municipal Board, Ormoc City a list of taxable real
properties and the list of names of delinquent tax payers
inspite of the fact that there had been a resolution to
that effect forwarded to his office last August, 1949;

RESOLVED FINALLY, to request the City Treasurer,
Ormoc City to explain within three days from receipt hereof
during the next special or regular session of the
Honorable Body a supplementary verbal explanation besides
the written one on the subject of tax collection afore-
mentioned.

Let copy of this resolution be furnished each to
the Honorable Secretary of the Interior, Manila; to the
Honorable Secretary of Finance, Manila; to the City Mayor
Ormoc City; to the City Treasurer, Ormoc City; and to the
City Auditor, Ormoc City.
