RESOLUTION NO. 19

AMENDING SECTION 15 LETTER "A" AND SECTION 18 OF
ORDINANCE NO. 6

The Board, on motion of Councillor Guillermo T.
Parrilla seconded by Councillor Victorino C. Teleron;

BE IT RESOLVED, as it is hereby resolved, to amend
Section 15 letter "A" and Section 18, respectively of
Ordinance No. 6 to increase water fees on flat rates and
to decrease water fees on water meters in this wise:

SECTION 15 LETTER "B" INCREASE OF CHARGES ON FLAT
RATES:

From 1 to 5 occupants from P2.00 increased to
P5.00 a month;
From 6 to 10 occupants from P3.00 increased to
P7.00 a month;
From 11 and above occupants from P4.00 increased to
P10.00 a month;
For any other domestic use, monthly just the P2.50.
For commercial use from P8.00 increased to P15.00
a month.

PRICES OF WATER FURNISHED THROUGH METER:

For the first 2000 cubic metersP .10 per cu.m.
All above 2000 cubic meters..... .08 " " "

SECTION 18: DECREASE OF CHARGES BY WATER METERS
FURNISHED BY THE SYSTEM ON RENTAL BASIS SHALL BE
RENTED AS FOLLOWS:

1/2 to 1" size.....P .50
Over 1" size..... 1.00

take effect beginning February 16, 1950;
