RESOLUTION NO. 22

WHEREAS, the Municipal Board of Ormog City is reliably informed that an American Contractor under took the construction of all barrier schools throughout the Philippines destroyed during the last world war for which \$3,000,000 was awarded by the Philippine War Damage Commission to undertake the rehabilitation project;

WHEREAS, the American Contractor aforementioned knowing that he could not finish the vast projects of the construction until June 30, 1949, said contractor withdrew the award of the Philippine War Damage Commission;

WHEREAS, the City Engineer, Ormog City in open session of the Municipal Board informed the Honorable Body that last 1948 he received a letter from Manila to report all the barrier schools within the City of Ormog which were destroyed during the last world war and which report was duly complied with by the City Engineer aforementioned and no answer was heard from;

WHEREAS, the Municipal Board, Ormog City is deeply concerned with the rehabilitation of barrier school buildings of Ormog City destroyed during the last world war which up to date are not yet reconstructed by the Philippine War Damage Commission;

NOW THEREFORE,

The Board, on motion of Councilor Margarito G. Yagosen duly seconded by Councilor Flaviano Montesclaros;

BE IT RESOLVED, as it is hereby resolved, to respectfully request the Philippine War Damage Commission, Manila, to order the City Engineer, Ormog City to submit again a report of all barrier schools of Ormog City which were destroyed or burned during the last world war so that the barrier schools of Ormog City could be rehabilitated;

BE IT RESOLVED FURTHER, to respectfully request Honorable Congressman Domingo Veloso, Speaker Pro-tempore of the House of Representatives, Honorable Mariano Jesus Cuenco, Senate President and Honorable Eugenio Perez, Speaker of the House of Representatives to intercede and make representation before the War Damage Commission, Manila for the release of war damage funds to rehabilitate the city government of Ormog for the school buildings in the barrier which were destroyed during the last world war;
