RESOLUTION NO. 30

WHEREAS, the City of Ormoc comprising 58 barrios, thickly populated by industrious and hard working farmers is highly and agricultural region;

WHEREAS, inspite of the limited financial capacity of the City Government concern, His Honor, the City Mayor, in answer to the earnest desire of the barrio people for construction of barrio vecinal roads, has at present undertaken a vast projects of barrio road construction in order to serve the best interest and welfare of his people;

WHEREAS, the City officials of Ormoc City believe that it is their prime duty to connect barrio roads to the main highway in order to give facility to the barrio farmers to transport their agricultural industries of corn, paly, abacca, tobacco and other forest products thus carrying out the policy of the present administration to achieve economic self-sufficiency thru encrease of food production;

WHEREAS, the election of Honorable Domingo Veloso as Speaker Protempore of the House of Representatives is not only a triumph of his policial leadership and a recognition of his high visional statemanship, but also a triumph of the small farmers scattered in the interior sitios and barrios who have been longing for transportation facilities but for lack of local funds to finance the project, their dreams are not yet materialized;

Conui in his vast the project of barrio road construction in order to solve the earnest desire of the barrio folks of Ormoc City to give them transportation facilities so that their agricultural products could be transported with facility to the consuming public;

BE IT RESOLVED FURTHER, to respectfully convey to Honorable Congressman Domingo Veloso that the Board is prompted to pass the present resolution in the interest

and welfare of the 80,000 inhabitants of the city of Ormoc who are sincerely proud of his election as Speaker Protempore of the House of Representatives and his well deserved election which has enhanced his political influence more financial aid could be extended to the barrio people of the City of Ormoc;
