RESOLUTION NO. 32

The Board, on motion of Councilor Rafael D. Omega,
seconded by Councilor Pablo S. Pajaron;

BE IT RESOLVED, as it is hereby resolved to appropriate the sum of \$245.00 to satisfy the demands for payment of Pioneer Press Incorporated, Cebu City contained in the statement of account dated February 9, 1950 addressed to the Municipal Board, Ormoc City for letter heads for the Office of the City Mayor and criminal identification cards for the Office of the Chief of Police;

BE IT RESOLVED FURTHER, that one third of the above amount is appropriated be taken from the contingent appropriation of the Office of the City Mayor, Ormoc City and two thirds of the same to be taken from the contingent appropriation of the Police Department, Ormoc City;

BE IT RESOLVED FURTHERMORE, to respectfully request the City Treasurer, Ormoc City to effect the reversion of fund as above stated in order not to unnecessarily delay the payment of the statement of account above mentioned for articles purchased on account of the Office of the City Mayor and of the Office of the Chief of Police, Ormoc City respectively;

BE IT RESOLVED LASTLY, to request the City Treasurer Ormoc City and the City Auditor, Ormoc City to approve the above reversion of funds in the amount above stated without further awaiting the approval of the President of the Philippines, the Secretary of Justice and the Auditor General as stated in the 4th indorsement dated March 6, 1950 of the City Treasurer, Ormoc City and the 5th indorsement of the City Auditor, Ormoc City dated March 6, 1950, in justice to the credit concerned which account is long overdue;

BE IT RESOLVED FINALLY, to furnish copy of this resolution each to the President of the Philippines, Malacañan Palace, Manila; to the Department of Justice Manila; to the Office of the General Auditor, Manila; to the City Mayor Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City to the Chief of Police, Ormoc City; and to the Pioneer Press Incorporated, Cebu City.

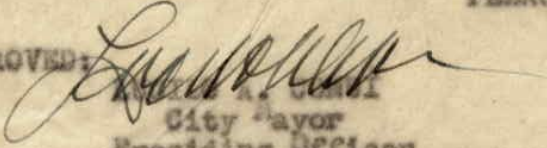
