APPORTIONMENT OF THE PCSO ALLOTMENTS

The 5th indorsement of Mr. Casiano Puray, Chief  
Sanitary Inspector, Ormoc City dated February 22, 1950

Respectfully returned to Hon. City Board, thru  
His Honor, City Mayor, Ormoc City, with the information  
that the undersigned had an interview with Mr. Marcos Pi-  
rante, Bookkeeper of the City Treasurer, in connection  
with the PCSO allotments. The amount of P8,500 is left  
for construction of City Hospital which was already  
appropriated by Hon. Board, and allotments of past draws  
excluding the foregoing amount, there is available amount  
of P1018.82 ready for appropriation in the maintenance  
of health and other charitable activities.

It is hereby informed that actually the public dis-  
pensary is not yet provided with operating table which  
is necessary in dispensary, so that this office respect-  
fully requests Hon. City Board that P600 is recommended  
for the purchase and the remaining amount, P518.82 for  
other health works or for fencing the Public Dispensary  
garden or other improvements.

BE IT RESOLVED FURTHER, that the amount of P600 allotted to the Public Dispensary, Ormoc City, if the same is to be used for the purchase of operating table for said dispensary said amount of P600 should not be used exclusively for the purchase of an expensive operating table as only dead persons are operated on the same;

BE IT RESOLVED FURTHERMORE, that the balance of the PCSO checks in the amount of P518.82 hereby allocated to the Puericulture Center, Ormoc City be turned over to the Puericulture Center, Ormoc City for its immediately essential needs;

BE IT RESOLVED FINALLY, to furnish copy of this resolution to the Acting General Manager, Philippine Charity Sweepstakes, Manila; to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City; to the Public Dispensary, Ormoc City; and to the Puericulture Center, Ormoc City.
