WHEREAS, in order to carry out the intensive and extensive campaign for the collection of taxes the City Treasurer has issued Office Order No. 37 series of 1950 and instruction letters dated March 3, 1950 which are implementation to effect substantial collection of taxes due the city government;

WHEREAS, the City Engineer, Ormoc City is an entity of the City government which could help the finance department of this city to improve its collection of taxes;

The Board on motion of Councilor Margarito G. Tugonon seconded by Councilor Cleto P. Evangelista;



BE IT RESOLVED FURTHER, to respectfully request the City Engineer, Ormoc City to submit a report to the Municipal Board, Ormoc City within one week hereof of those owners of houses who have paid their building permit required by law and those persons who have failed to pay such building permit;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; the City Treasurer, Ormoc City; the City Engineer, Ormoc City; and the City Auditor, Ormoc City.
