RESOLUTION NO. 52

WHEREAS, Honorable Congressman Domingo Veloso of the second district of Leyte by second indorsement dated February 8, 1950 recommended to the City Council of Ormoc City to approve a resolution on the construction of a road project to barrio Manlilinao, Ormoc City using gasoline fund national aid for the purpose without prejudice to his granting additional fund from his pork barrel in 1950-1951;

WHEREAS, the Honorable Speaker Protempore requested the Municipal Board of Ormoc City to give preferential consideration on this road project as a pork barrel fund would be available around the month of August and September this year to complete the work;

WHEREAS, the Municipal Board, Ormoc City acting on the request of Congressman Domingo Veloso and on the letter of Mrs. Concepcion M. Espina dated January 30, 1950 addressed to His Honor, Honorable Lucilo A. Conui, City Mayor of Ormoc City wholeheartedly approved the indorsement of Congressman Veloso as the construction of barrio vehicular road is the pet project of the administration of the City Mayor;

NOW THEREFORE,

The Board, on motion of Councillor Rafael D. Omega seconded by Councillor Pablo S. Pajaron;

BE IT RESOLVED, as it is hereby resolved to respectfully request Mrs. Concepcion M. Espina to execute a deed of donation in favor of the City Government of Ormoc City or a road right of way agreement in favor of the city on the proposed road project so that steps could be immediately taken by the Municipal Board on the proposed road project to barrio Manlilinao;

RESOLVED FINALLY, to furnish copy of this resolution each to Hon. Congressman Domingo Veloso, Speaker Protempore, House of Representatives, Manila; to Mrs. Concepcion M. Espina, Puerto-Bello, Merida, Leyte; the City Mayor, Ormoc City; the City Treasurer, Ormoc City; the City Auditor, Ormoc City and the City Engineer, Ormoc City.
