### Gentlemen:

I have the honor to inform the Honorable Body that the reconstructions of the Home Economics and the two (2) Shop Buildings could not be completed due to the fact that the total amounts of awards from the Philippine War Damage Commission have already been exhausted, being really insufficient to meet th expenditures for the whole constructions.

In view of which, I am requesting that Honorable Body to set aside any available city funds, within their power which I recommend to be appropriated for:

1. Completion of the Home Economics Building with Exterior Painting ---- P2,500.00 2. Completion of Shop Building No. 1-A

with Exterior Painting - - - - - 3. Completion of Shop Building No. 3 -- 1,600.00

with Exterior Painting ------- 2,200.00

The above request and recommendation are based upon the conditions set forth by the PwDC, as per copy of such letter hereto attached and the pertinent portions of the provision of Article V of the Agreement between the U.S.A. and the Republic of the Philippines regarding the payment of public and private claims, quoted hereunder:

#### - Page Two -

"After a project is initiated, if such funds are found to be in excess of the requirements, such excess shall be returned to the Commission, and if the funds are found to be insufficient the Government of the Republic of the Philippines shall complete the work, or a useful unit thereof, from its own funds. The Commission shall not be obligated to advance funds except as the work progresses and the Commission is satisfied that all the terms of this Agreement are being met".

Manila to kindly consider the bilitation of the buildings aforementioned by granting additional award in the amount requested by the City Engineer above quoted in order to complete the aforementioned building.

BE IT RESOLVED FURTHER, to respectfully convey to the Honorable Philippine War Damage Commission that the present appeal for additional award is based on a well founded ground that in the opinion of the City Council the total
