Sirs:

I have the honor to recommend for a transfer the amount of fifty pesos (P50.00) under item of other services to traveling expenses and per diems under the present Budget-Plantilla of the Agricultural Department.

The Two Hundred Fifty Pesos (P250.00) appropriated for traveling expenses and per diems is already consumed when I was called to attend the Agricultural Convention in Manila. The transfer of the said amount is very necessary for the traveling expenses and per diems of the personnel of this department for conducting food production campaign during the months of February to June inclusive.

It is therefore requested that early favorable consideration for this recommendation is very much desired.
