RESOLUTION NO. 73

The letter of Mr. Felicisimo Mabao, Acting District
Supervisor, Ormoc District I dated April 4, 1950 and first
indorsement of the City Treasurer, Ormoc City dated April
11, 1950 hereunder quoted verbatim respectively as follows:

Gentlemen:

Your attention is invited to the inclosed claim Voucher
dated March 27, 1950 at P9.00 only, for the payment of the light
furnished the elementary school for the months of May and June
1949.

Because of the very late claim, and the said claim having
not been obligated before the final closing of accounts last
June 30, 1949, I have the honor to recommend to the Hon. City
Municipal Board that this just obligation of the City Govern-
ment be paid from the unexpended balance of P2,000.00 school
saving for district I. It will be for the information of the
Board that the two lights(bulbs) furnished the elementary
school is part of the City streets lighting per contract of
the City government with the Ormoc Electric Light Co. When
in 1947-1948 we received the National allotment for lighting
we took advantage to have this paid from it. Last school
year and this year however, we have not received any allot-
ment for it.

Keeping the two lights(bulbs) in the City Central School
is urgently needed as the school janitors need them while
they watch the National and City school properties every
night.
