RESOLUTION NO. 82

WHEREAS, the Municipal Board, Ormoc City on May 27th a.s. regular session of the Board was officially informed by His Honor, Lucilo A. Conui, City Mayor of Ormoc City of the letter of Honorable Manuel Cuenco, Provincial Governor of Cebu quoting the telegram of Congressmen Cince and Durano that bill on local autonomy granting governors to appoint provincial employees was approved;

WHEREAS, Honorable Manuel Cuenco, Provincial Governor of Cebu stated further in said communication that the bill granting more local autonomy was already approved by the Senate and that it lacks only the signature of the President of the Philippines to convert the same into law;

BE IT RESOLVED, as it is hereby resolved to express the gratitude of the Municipal Board of Ormoc to Congressmen Atilano Cince and Ramon Durano for their efforts and interest they have contributed in the fight in the Hall of Congress towards the bill on local autonomy;

BE IT RESOLVED FINALLY, to furnish copy of this resolution each to Senate President Mariano Jesus Cuenco, Manila; to Honorable Eugenio Perez, Speaker House of Representatives Cebu, Cebu City; to Honorable Atilano Cince, Congressman of the 5th district, Leyte; to Congressman Ramon Durano, 1st district, Province of Cebu and to Congressman Domingo Veloso, Speaker Protempore, House of Representatives, Manila;
