Letter of Mr. Valentin Halasan, City Auditor, Ormoc City, dated June 16, 1950 and 1st Indorsement of Mr. G.A. Villas, Acting Administrative Deputy dated June 17, 1950 and the 2nd Indorsement of the City Mayor, Ormoc City of even date, quoted verbatim, respectively, as follows:

Gentlemen:

I have the honor to request that the amount of Six Hundred (P600.00) Pesos be reverted from the appropriation for travel of this Office, the same to be appropriated for the purchase of one (1) typewriter, one (1) filing cabinet, four (4) ordinary chairs and two (2) desk glasses. In this connection, information is given that although the purchase of a filing cabinet was authorized in the last annual budget and the amount of Three Hundred (P300.00) Pesos appropriated therefor, the requisition could not be filled due to lack of funds. The lack of funds was due to the low estimate on the cost of typewriter and filing cabinet. In view hereof, it is requested that the herein reversion of funds be approved.
