Sir:

I have the honor to inform that in the plantilla for
1949-1950, it appears that the item of five (5) market cleaners
belong to the office of the City Treasurer. In as much as
these positions have been questioned by the Bureau of Health,
on the reason, that the nature of work concerns to health acti-
vities, this office is instructed by the Bureau of Health to make
representation to Hon. City Board, requesting transfer of posi-
tions in question, from the City Treasurer to City Health Officer,
in order that their appointments could be acted accordingly.

In view of the above explanation, it is earnestly requested
that early action should be taken to hasten the delayed appoint-
ments of the market cleaners.

Secretary of Health, Manila thru the City Health Officer, Ormoc City for their guidance and action; to the City Mayor, Ormoc City, and the City Auditor, Ormoc City;
