RESOLUTION NO. 119

WHEREAS, His Honor, the City Mayor, Ormog City informed the Honorable Members of the Municipal Board of Ormog City the verbal reports of principals of Ormog District I that there are school children not only from the municipality of Cananga but also from other municipalities outside the jurisdiction of Ormog City that are enrolling in the city schools of the City of Ormog;

WHEREAS, His Honor further informed the Honorable Body that under this state of facts he wanted the opinion of the Board whether we should admit or not these non-residents school children to be enrolled in the city schools of Ormog;

WHEREAS, Councillor Pablo S. Pajaron informed the Honorable Body of the existing regulations of the Director of Bureau of Public Schools that all pupils in any locality must be admitted for enrollment to which His Honor, the City Mayor expressed his opinion that all rules and regulations of Public Schools should be followed;

WHEREAS, Councillor Margarito G. Yugonon also manifested that the school children, residents outside the City of Ormog could be allowed to enroll in the city intermediate schools of Ormog City, however, preference for enrollment should be given to children who are bona-fide residents of the City of Ormog;

WHEREAS, Councillor Margarito G. Yugonon clarifying further his stand informed the Honorable Body that inasmuch as it is the city government of Ormog City who appropriates fund to pay the salaries of the city intermediate school teachers, the students residents of the City of Ormog should be accommodated first for enrollment in our city intermediate schools. That non-residents could be enrolled in our city intermediate schools only on condition that there are still rooms left to accommodate them with the further condition that non-resident pupils who seek to enroll in the City intermediate schools of Ormog City be required to pay twice the tuition fees required of pupils who are bona-fide residents of Ormog City;

NOW THEREFORE;

The Board, on motion of Councillor Margarito G. Yugonon seconded by Councillor Antonio C. Cataag;

BE IT RESOLVED, as is hereby resolved, to amend Section 2 of Resolution No. 195, Ordinance No. 12 series of 1948 to the effect that non-residents students heretofore, who desire to be enrolled in the city intermediate schools of Ormoc City should pay twice or double the tuition fees required of pupils residents of Ormoc City thus amending Section 2 of Resolution No. 195, Ordinance No. 12 series of 1948;

BE IT RESOLVED FURTHER, that the standing rules and regulations prescribed by the Director of the Bureau of Public Schools with respect to the enrollment of non-residents and residents pupils in the City intermediate schools of Ormoc City consistent with the aforementioned amendment, shall be followed;

BE IT RESOLVED FURTHERMORE, that the admission of non-residents pupils in the city intermediate schools of Ormoc City could only be allowed if there are enough rooms to accommodate them, provided further that said non-residents seeking enrollment in the city intermediate schools of Ormoc City are willing to pay double the tuition fees as above stated;

BE IT RESOLVED FINALLY, to furnish copy of this resolution each to the Director of Public Schools, Manila; to the Division Superintendent of Schools, Tacloban, Leyte; the City Mayor, Ormoc City; the City Treasurer, Ormoc City; the City Auditor, Ormoc City; the District Supervisor of Ormoc District I, Ormoc City; and the District Supervisor of Ormoc District II, Valencia, Ormoc City.
