RESOLUTION NO. 111

WHEREAS, on formal manifestation of Councillor Pablo S. Pajaron calling attention to the Honorable Body, the Municipal Board of Ormoc City that the District Supervisor of Ormoc District I, Mr. Felicisimo Yabao has failed to advise or extend a little courtesy to the Municipal Board of Ormoc City for authority to open or not the city intermediate schools of this city, deserves deliberation of the Honorable Body;

NOW THEREFORE,

The Board, on motion of Honorable Pablo S. Pajaron, City Councillor of Ormoc City seconded by Honorable Guillermo T. Parrilla, City Councillor;

BE IT RESOLVED, as is hereby resolved to respectfully informed the District Supervisor of Ormoc District I, Mr. Felicisimo Yabao to temporarily open those intermediate classes of Ormoc City which were opened last school year (1949-1950) on two grounds:

First, for failure to make representation of said District Supervisor of Ormoc District I to the Municipal Board of Ormoc City requesting authority to open intermediate classes in said District I.

Second, on the ground that the City finance, to support the opening of the intermediate classes is falling and is therefore subject to readjustment during the deliberation of city budget for the ensuing fiscal year;

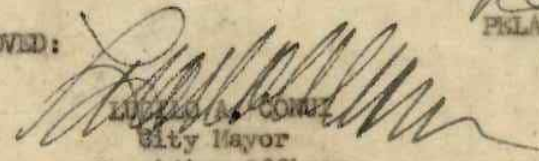
