RESOLUTION NO. 127

Letter of Dr. Petronilo L. Torres, City Health
Officer, Grace City dated July 7, 1950 addressed to the
Honorable Municipal Board thru the Honorable City Mayor,
Grace City hereunder quoted verbatim as follows:

The Municipal Board
Thru the Hon. City Mayor
Grace City

I have the honor to inform you that the market place
in Barrio Valencia is indeed very deplorable. As it is now,
there are conglomeration of small dilapidated nipa shacks
which are dirty and insanitary. During the dry season, it
is too dusty and during the wet season, it is likewise too
muddy. To have a market like that within the jurisdiction
of a city like this, is rather a discredit to the public
officials in particular and to the city itself in general.

In this connection, I earnestly request the Honorable
members of the Municipal Board to construct a public mar-
ket building in the said barrio. This building does not
need to be concrete and very expensive one. I believe that
a wooden building with galvanized iron roofing will do, pro-
vided it will have cement flooring and a toilet for the pub-
lic.

Aside from the fact that city can get big financial in-
come from this proposed market, the sanitary aspect of the
same can be well and effectively supervised by the City
Health Department.

Hoping for your favorable action on this important city
project.

BE IT RESOLVED FURTHERMORE, to inform *frindin*, the City Health Officer to the object of the Board on the statement in his letter above quoted which says that (is rather a discredit to the public officials in particular and to the city itself in general) informing said official that the same be stricken out of the record;

BE IT FINALLY RESOLVED, to furnish copy of this resolution each to the City Mayor, Ormoc City; the City Engineer, Ormoc City; the City Health Officer, Ormoc City; The Chairman, Committee on Appropriations; and to the Chairman, Committee on Health Public Welfare and Market.
