RESOLUTION NO. 119

WHEREAS, the Chair called the attention of the honorable
Body on the necessity of amending Resolution No. 110 c. s.
amending Section II of Resolution No. 195, Ordinance No. 12
series of 1948 on the question of the defining the word residence
for the purpose of enrolment of pupils in the intermediate
classes of Ormog City schools;

WHEREAS, Councillor Cleto P. Evangelista manifested that
Resolution No. 110 c. s. amending Section II of Resolution No. 195
Ordinance No. 12 series of 1948 used the word non-residents in-
stead of residence for the purpose of being admitted for enrolment
in the city intermediate schools of Ormog City;

WHEREAS, the Chair maintains that in order to avoid dis-
cussions later on, of the meaning of non-resident pupils there is
a necessity of amending Resolution No. 110 c. s. above mentioned
for the purpose of clarifying the meaning of resident and non-
resident for the purpose of enrolment in the intermediate classes
of the city of Ormog;

NOW THEREFORE;

The Board, on motion of Councillor Cleto P. Evangelista
seconded by Councillor Margarito G. Tugonon;

BE IT RESOLVED, as is hereby resolved to amend Resolution
No. 110 c. s. amending Section II of Resolution No. 195, Ordinance
No. 12 series of 1948 to the effect that there should be a mandatory
resolution to basic resolution No. 110 for the purpose of defining
the word non-residence which shall be understood to mean "Any
person who has not resided continuously for six (6) months prior
to his or her enrolment in the intermediate schools of Ormog city
and not continue to reside therein thereafter";

BE IT RESOLVED FURTHER, that the residence or non-residence
of the parents for the purposes of enrolment of their children
in the intermediate schools of Ormog City affect likewise the
residence or non-residence of their children; should such children
happen to be still a minor;

BE IT RESOLVED FINALLY; to furnish copy of this resolution
each to the City Mayor, Ormog City; the City Treasurer, Ormog City;
the City Auditor, Ormog City; the Principal in-charge of Ormog

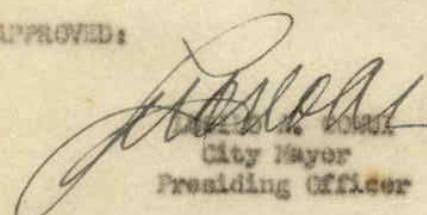
