RESOLUTION NO. 120

ACTION OF THE BOARD ON MONTESCIAROS APPROPRIATION

WHEREAS, the Municipal Board on its deliberation tentatively on the city budget for 1950-1951 was uprisen by the city treasurer, Mr. Menandro Teleron on different items of the continuing appropriation namely: P2,000 for the construction of slaughter house; P1,000 for the construction of garage of the Fire Department; P2,000 for the construction of Rizal's Monument; and P5,000 for the construction of city jail of Ormoc City;

WHEREAS, the city treasurer, Ormoc City in open session of the Board on July 14, 1950, special meeting, has informed the Honorable Body on the availability of funds on the four projects above mentioned;

WHEREAS, the Municipal Board on the suggestion of Councilor Rafael D. Omega requested the Honorable Body to create a committee of three to look for a site where the market slaughter house of Ormoc City could be constructed;

WHEREAS, it was unanimously agreed that the committee of three should be members of the Municipal Board with the City Health Officer of Ormoc City as Chairman of said committee, thus: Dr. Petronilo L. Torres, City Health Officer of Ormoc City as Chairman of the Committee; Councilor Guillermo T. Parrilla - Member; Councilor Pablo S. Pajaron - member; and Councilor Antonio C. Cataag - member;

WHEREAS, the Municipal Board, in order to expedite the prosecution of the above mentioned projects further respectfully request the City Engineer of Ormoc City to make the plans and specifications of the above mentioned projects based on the appropriations of the respective projects above mentioned and submit the same as early as possible to the Municipal Board;

NOW THEREFORE;

The Board, on motion of Councilor Pablo S. Pajaron seconded by Councilor Cleto P. Evangelista;

BE IT RESOLVED, as is hereby resolved to construct a slaughter house for Ormoc City which carries an appropriation of P2,000; garage for the Fire Department in the amount of P1,000; a city jail which carries an appropriation of P5,000; and Rizal's monument in the amount of P2,000 of which projects above mentioned are continued appropriation, the availability of funds for their

respective construction having been certified by the City Treasurer of Ormoc City;


BE IT RESOLVED FURTHER, to respectfully request the City Engineer, Ormoc City to immediately make the plans and specifications for the above mentioned projects in order to expedite the construction of the same, requesting further said City Engineer to suggest the best site for the construction of the city jail and the garage of the Fire Department; and with regards to the construction of the slaughter house the committee above created could be consulted with as to its site; and as to the construction of Rizal's monument the same shall be constructed in front of the City Hall at the middle of its entrance, provided further that all the construction of the above mentioned projects should be adjusted to their respective appropriation above mentioned;

BE IT RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; the City Treasurer, Ormoc City; the City Auditor, Ormoc City; the City Engineer, Ormoc City; the City Health Officer, Ormoc City; the Chief of Police, Ormoc City; the Chief Fire Department, Ormoc City; and to the Market Superintendent, Ormoc City;




