The Board, on motion of Councilor Margarito G. Tugonon
seconded by Councilor Cleto P. Evangelista,

BE IT RESOLVED, as is hereby resolved that pending the final approval of the city budget for Ormoc City for the fiscal year 1950-1951, Mr. Felicisimo Yabao, Principal in-charge of Ormoc District I, is hereby authorized to open the three intermediate classes in response to the increase enrolment of pupils as reported by him for the school year 1950-1951, and to open or create three new positions in same intermediate classes, two classes in the central and one in Barrio Curva, requesting further said principal in-charge to submit list of the names and educational qualifications of the teachers assigned to those three positions above mentioned, the same to receive the same salaries with the other teachers recommended by him in his plantilla at P50.00 a month provided said teacher is only a normal graduate, and provide further that the normal graduate should not received the same salary as the BSE graduate;

BE IT RESOLVED FINALLY, to furnish copy of this resolution to the City Mayor, Ormoc City; the City Treasurer, Ormoc City; the City Auditor, Ormoc City; the Principal in-charge of Ormoc District I, Ormoc City; and the District Supervisor of Ormoc District II, Valencia, Ormoc City.
