The Board acting on the representation of Mr. Felix A. de Veyra, District Supervisor of Ormoc District II, Ormoc City, on motion of Councilor Margarito G. Tugonon seconded by Councilor Antonio C. Cataag;

BE IT RESOLVED, as is hereby resolved to open five (5) additional intermediate classes in Ormoc District II excluding the intermediate classes in the newly created Municipality of Cananga without creating additional positions to the same to be allocated to the following barrios: Two (2) intermediate classes in Barrio Maticaa; One (1) in Barrio San Jose; One (1) in Barrio Catayun; and One (1) in Barrio Valencia, provided further, that the designation of a principal teacher for barrio Maticaa Intermediate School be held under consideration by the Municipal Board which Body shall inform later on the action of the Board on the designation of said principal teacher in said barrio Maticaa;

BE IT RESOLVED FURTHER, to respectfully request said District Supervisor of Ormoc District II to submit to the Municipal Board his plantilla of personnel;

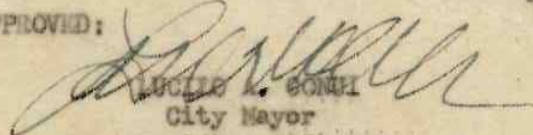
