RESOLUTION NO. 129

WHEREAS, be it known that in order to solve the precarious financial condition of the city due to the discovery of the same during the tentative deliberation of the budget of the Appropriation Committee on the Municipal Board for the fiscal year 1950-1951, the City Mayor, His Honor, Lucilo A. Conui immediately called for a conference on July 27, 1950 of all Department Heads of the city government of Ormoc to find means and ways of solving the deficit of the city;

WHEREAS, during said conference of all Department Heads held in the Office of the City Mayor, it was unanimously agreed that in order to solve the deficit of the city, there should be a cut or slash in salaries of all city employees to 15% effective July 1st, 1950;

NOW THEREFORE;

The Board, on motion of Councilor Margarito G. Tugonon seconded by Councilor Pablo S. Pajaron;

BE IT RESOLVED, as is hereby resolved to authorize the City Mayor of Ormoc City to notify each and every department heads of the city government of Ormoc city that effective July 1st, 1950 all employees of personnel including each and every department heads of the city government of Ormoc shall suffer a slash or reduction by 15% of their salaries as agreed in principle by the department heads during the conference aforementioned;

BE IT RESOLVED FURTHER, that the reduction of salaries aforementioned be made with the condition that in the event that the financial condition of the city would improve so as to warrant the restoration of the reduction of 15% above mentioned, said reduction of 15% shall be lifted and the old salaries shall be restored and that said restoration of salaries shall be made retroactive;

BE IT RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. the Secretary of the Interior, Manila; the Hon. Sec. of Finance, Manila; the City Mayor, Ormoc City; and the City Treasurer, Ormoc City; the City Auditor, Ormoc City; and the rest of the City Department Heads of the city government of Ormoc City.
