WHEREAS, be it known that in order to solve the precarious financial condition of the city due to the discovery of the same druring the tentatible deliberation or the budget of the Appropriation Committee on the Aunicipal coard for the fiscal year 1950-1951, the City Mayor, his Honor, Lucilo A. Conui immediately called for a converence on July 27, 1950 of all Department Heads of the city opvernment of Ormoc to find means and ways of solving the defict of the city;

WHEREAL during said conference of all Department Heads held in the Office of the City Mayor, it was unanimously agreed that in order to solve the deficit of the city, there whould be a cut of Mash in salaries of all city employees to 15% effective Vuly 1st, 1950;

HE IT RESOLVED, as is hereby resolved to authorize the Olty Mayor of Ormoc City to notify each and every department heads of the city government of Ormoc city that effective July 1st, 1650 all employees of personnel including each and e very department heads of the city government of Ormoc shall suffer a slash or reduction by 15% of their salaries as agreed in principle by the department heads during the conference aforementioned;

BE IT RESOLVED FURTHER, that the reduction of salaries aforementioned be made with the condition that in the event that the financial condition of the city would improve so as to warrant the restoration of the reduction of 15% above mentioned, said reduction of 15% shall be lifted and the old salaries shall be restored and that said restoration of salaries shall be made retroactive;

BE IT RESOLVED FINALLY, to furnish copy of this resolution each tothe Hon. the Secretary of the Interior, Manila; the Hon.Se. of Finance, Manila; the CityMayor, OrmocCity; and the City Treasurer, OrmocCity; the City Auditor, OrmocCity; and the rest of the City Department Heads of the city government of OrmocCity.
