RESOLUTION NO. 133

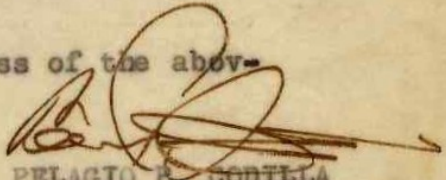
The Board, on motion of Councilor Flaviano Montesclaros seconded by Councilor Antonio C. Cataag;

BE IT RESOLVED, as is hereby resolved to request the Director of Public Schools, Manila for permission to open, operate and maintain a third year high school class in the Ormoc City high school beginning July 1st, 1950;

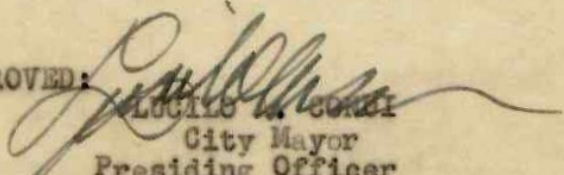
BE IT RESOLVED FURTHER, to respectfully inform the Director of Public Schools aforementioned that beginning July 1st, 1950 the third year High School class in the Ormoc City High School begun to open on that date as informed by the Principal of said high school, Mr. Carlos Petilla, but due to the pressure of official business of the Board on the deliberation of the budget, formal resolution requesting the Director of Public School for the opening of said third year high school class was not deliberated by the Honorable Body for which reason the official concerned is respectfully requested to authorize the opening of the third year high school class at the Ormoc City High School effective as of July 1, 1950.

BE IT RESOLVED FINALLY, to furnish copy of this resolution each to the Honorable the Secretary of the Interior, Manila; to the Honorable Secretary of Finance, Manila; to the Honorable Director of Public Schools thru the Division Superintendent, Tacloban, Leyte; to the City Mayor, Ormoc City; the City Treasurer, Ormoc City; the City Auditor, Ormoc City; and to Mr. Carlos Petilla, Principal of Ormoc City High School, Valencia, Ormoc City.
