RESOLUTION NO. 134

WHEREAS? the City Auditor, Ormoc City addressed a letter to the Municipal Board, Ormoc City through the City Mayor enclosing circular letter dated June 30, 1950 of the Honorable the Auditor General requesting additional appropriation of P480 to raise the present salary of the assistant city auditor from P1,800 to P2,280 per annum this making the position exactly one grade below that of the assistant city treasurer of Ormoc City so that the salary of the assistant city auditor would be raised from P150 to P190 per month or P2,280 per annum;

NOW THEREFORE,

The Board, on motion of Councilor Flaviano Montesclaros seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved to increase the salary of the assistant city auditor, Mr. Daciano Balami to P10 per month thus raising the salary from P110 to P160 per month;

BE IT RESOLVED FURTHER, to respectfully inform the Honorable the Auditor General, Manila thru the city auditor, Ormoc City that full justification of the schedule of salaries provided for in Executive Order No. 94 dated October 4, 1947 could not be followed due to the present policy of the city government of Ormoc not to increase salary of employees due to the recent order of the Finance Department, Manila to decrease the internal revenue allotment of the city to 50%; and the creation of Cananga as a new independent municipality; thus affecting vitally the finance of the city government;

RESOLVED FINALLY, to furnish copy of this resolution each to the Secretary of the Interior, Manila; the Honorable Secretary of Finance, Manila; the Honorable General Auditor, thru the City Auditor, Ormoc City; the City Mayor, Ormoc City; the City Treasurer, Ormoc City.
