WHEREAS, on the manifestation of Vice Mayor, Marcelo D. Bandalan, with regards to the request of the City Engineer for the purchase of a new jeep above quoted, the Vice Mayor

informed the Honorable Body that he happened to have a talk with said City Engineer, who conveyed to him the idea that, considering that the position of the Asst. Civil Engineer was already abolished the City Engineer proposed to ^{loan} the jeep of the Asst. Civil Engineer to the Municipal Board of Ormoc City for the exclusive use of members of the Honorable Body with the further condition that the gasoline consumption and the salary of the driver for the official use of the members of the Municipal Board would be borne by the Engineering Department;

WHEREAS, Vice Mayor, Bandalan strongly recommended for approval, the request of the City Engineer for the purchase of a new jeep above quoted;

NOW THEREFORE, the Board, on motion of Vice Mayor, Marcelo D. Bandalan seconded by Councillor Pablo S. Pajaron;

BE IT RESOLVED, as is hereby resolved, to authorize the City Engineer, Ormoc City to purchase a new jeep by effecting the transfer of the amount of P4,045.00 under J-79 to J-71, for the purchase of a new jeep as requested in the above quoted communication.

RESOLVED FURTHER, to accept with thanks, the generous proposition of the City Engineer, Ormoc City to ^{loan} to the Municipal Board of Ormoc City the old jeep used by the Asst. Civil Engineer whose position is already abolished, under the terms and condition above manifested by Vice Mayor Bandalan, to the effect that the old jeep thus loaned to the Municipal Board, for the official use of the members of the Honorable Body be provided with a driver whose salary shall be defrayed by the Engineering Department and its gasoline consumption, also borne by said Engineering Department.

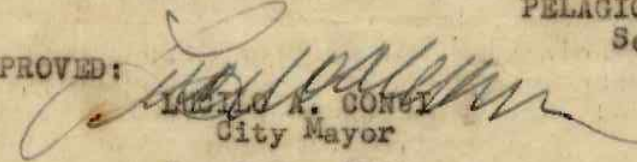

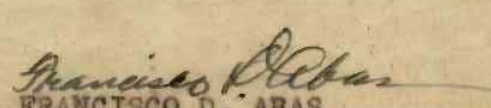
