RESOLUTION NO. 161

WHEREAS, the Municipal Board, Ormoc City, approved Resolution No. 125 C.S., which resolution selected as Slaughter House Site that space located at the end of Lopez Jaena St., near the bank of Anilao River;

WHEREAS, the City Engineer brought to the attention of the Municipal Board that upon constructing the foundation of the slaughter house on the site indicated in said Resolution, portion of the land was claimed be private owners;

WHEREAS, the Municipal Board created a committee of one, designating Hon. Councilor Porfirio Ayuyao to make further verification on the site of the proposed slaughter house site with authority to suggest to the Honorable Body the best site where the slaughter house should be constructed;

WHEREAS, Honorable Porfirio Ayuyao, the committee of one aforementioned, recommended that the slaughter house site for Ormoc City be constructed on the lot belonging to the City Government of Ormoc at the end of Lopez Jaena St. on the intersection of said Lopez Jaena St. and Juan Luna Street;

WHEREFORE, The Board, on motion of Councilor Porfirio Ayuyao, seconded by Councilor Flaviano Montesclaros;

BE IT RESOLVED, as is hereby resolved, to partly modify resolution No. 125 c.s. to finally approve the recommendation of Councilor Porfirio Ayuyao, committee of one, that the slaughter house site should be constructed on the lot owned by the City Government of Ormoc City at the end of Lopez Jaena St. on the intersection of Said Lopez Jaena Street and Juan Luna Street;

RESOLVED FURTHER, to furnish copies of this Resolution each to the City Mayor, Ormoc City, to the City Treasurer, Ormoc City; to the City Engineer, Ormoc City and the City Auditor, Ormoc City.
