RESOLUTION NO. 162

WHEREAS, the Honorable, the Acting Undersecretary of Finance, Sixto Arce, in his official communication, dated September 22, 1950 addressed to the Honorable Municipal Board of Ormoc City, then the City Treasurer, Ormoc City, has informed the Honorable Municipal Board concerned, denying the permission granting the City Treasurer to go to Manila on official business for the purpose of submitting current appropriation ordinance to the Department of Finance per Resolution No. 136, c.s. of the Municipal Board, Ormoc City;

WHEREAS, upon deliberation of the Municipal Board of the aforementioned communication of the Honorable Undersecretary of Finance, the Municipal Board of Ormoc City unanimously approved the present resolution requesting the Department of Finance, Manila to reconsider the disapproval of the official trip of the City Treasurer concerned, for the reason that said resolution No. 136 as approved by the Board was indispensable, because the Honorable Body honestly believes that said appropriation ordinance requires explanation on technical matters touching on said appropriation ordinance and the only technical official to make such representation and explanation is no other than the City Treasurer of Ormoc City;

NOW THEREFORE, on motion of Councilor Pablo S. Pajaron, seconded by Vice Mayor, Marcelo D. Bandalan;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Honorable Undersecretary of Finance, to reconsider his communication denying the official trip already made by the City Treasurer concerned in compliance with Resolution No. 136, aforementioned as said official trip has already been undertaken in good faith and in line with the policy of the present administration to give more autonomy to local government;

RESOLVED FURTHER, to respectfully convey to the authorities concerned of the Department of Finance, that the desire of the Board in approving Resolution No. 136 aforementioned was motivated by its honest intention to hasten the approval of said appropriation ordinance and

for that purpose in order to avoid delay, the representation of the City Treasurer concerned was utilized as he is the only technical man on the matter to explain technical questions which requires explanation;

RESOLVED FURTHERMORE, to respectfully request Honorable Congressman Domingo Veloso, to intercede in behalf of the Municipal Board of Ormoc City, to make representation to the Department of Finance and work for the reconsideration of this matter with a view to make official the trip already undertaken by the City Treasurer of Ormoc City in compliance with Resolution No. 136, of the Municipal Board disapproved by the Honorable the undersecretary of Finance;

RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable Secretary of the Interior, Manila; to the Honorable Secretary of Finance, Manila; to Honorable, Congressman Domingo Veloso, Speaker Pro-tempore, House of Representatives, Manila; to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City and to the City Auditor, Ormoc City.
