It has been noted that in the budget for the Fiscal Year 1950 - 51, appropriation for Communications has been omitted. This Office therefore request that Hon. Body to appropriate One Hundred Pesos (P100.00) for this purpose, to enable this Office to act on urgent communications without delay.

Based on the report of this office to the Hon. City Mayor, dated October 18, 1950, regarding the defects of the City Jail, this Office requests that an appropriation of Four Hundred Fifty Pesos (P450.00) for the purchase of the following be created:

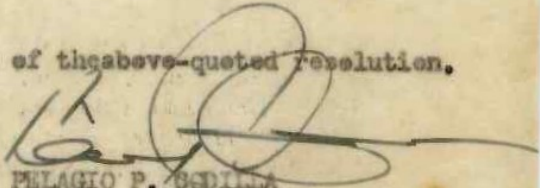

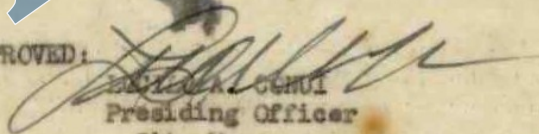

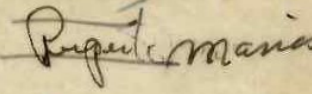
