Dear Sir:

Upon receipt of a copy of the city budget for the fiscal year 1950-51, I have noted that one position of the school janitor recommended by you is not included in the plantilla of the said budget. The Office of the Treasurer, thru the city municipal board may be requested to make a supplemental budget appropriating the amount of P840.00 to be taken from the home economics' appropriation of P2870.00. This therefore, does not alter the totals of the current budget. The appropriation for the home economics therefore will only have P2030.00. This amount is enough because there is still available P1900 from the war damage for home economics.

It will be for your information that Mr. Timoteo Wenceslao (your recommended) started to work as janitor the period from August 1 up to the present.
