RESOLUTION NO. 133

WHEREAS, the City Mayor, further informed the Board, that the Division Superintendent of Schools, Mr. Isabelo Manalo, has informed him that the condition of the Ormoc Central School premises does not meet the requirements so as to be eligible for the establishment of Athletic Center;

NOW THEREFORE, the Board, on motion of Councilor Porfirio Ayuyao, seconded by Cleto P. Evangelista;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Division Superintendent of Schools, Tacloban, Leyte, to furnish the Municipal Board of Ormoc City, a complete data of the requirements of the authorities concern for establishing Athletic Center in the Province, so that the city of Ormoc would be fully informed of the requirements with a view of being eligible for the establishment of Athletic Center.

FINALLY RESOLVED, to furnish copy of this resolution, each to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City; to the City Supervisor, Ormoc City; and to the Division Superintendent of Schools, Tacloban, Leyte.
