Respectfully returned to the Honorable, the Secretary of Finance, Manila.

This Department is agreeable to the inscription of the names of the City Councillors of Ormoc in the bronze plaque called for in the attached Requisition No. 49186, dated June 30, 1950, of said City, except the name of Councillor Antonio C. Cataag, who appears to have only replaced Councillor Esteban C. Cesejoc, and, therefore, not apparently among the first elected councillors of the City of Ormoc. Instead former Councillor Antonio C. Cataag's name should be inscribed on the plaque if he was among the first city councillors elected who assumed office.

Respectfully returned to the City Treasurer, Ormoc City, inviting attention to the 3rd Indorsement hereon of the Department of Interior, in connection with the names approved for the proposed bronze plaque for the Session Hall of that City, and to the enclosed full size detail of said plaque. It will be noticed that the size of the plate has been reduced from 12" x 24" to 12" x 18" and the name of Councillor Antonio C. Cataag has been omitted from the list in view of information furnished this Office that

he has been appointed to his position and not elected.

This Office also noted that "Ormoc City" is located under "First Elected City Councilors." It is requested that the appropriateness of such an arrangement be re-studied and whether placing "Ormoc City" at the head of the tablet will not be an improvement.

The comment and recommendation of the City Officials concerned on the matter is therefore requested, so that final action on the full size drawing may be taken by this Office.

BE IT RESOLVED, as is hereby resolved, to approve the amendment suggested in the above-quoted instrument in connection with Requisition and Issue Voucher dated June 26, 1952 of the Municipal Board, Ormoc City regarding Bronze Plaque of City Councilors for the Session Hall of the Municipal Board, Ormoc City on the following corrections:

1. That "Ormoc City" appearing in the attached sketch be placed above the words "First Elected City Councilors".
2. That the size be reduced to 12" x 18" instead of 12" x 24".
3. That the name of Councilor Antonio C. Cataag be stricken out.

RESOLVED FURTHER, to respectfully convey the courtesy and thanks of the Municipal Board of Ormoc City to the Director of Public Works and the Hon. Secretary of Interior, respectively, for the timely suggestions of the former and the approval of the latter, on Requisition Voucher No. 47108 above mentioned.

RESOLVED FINALLY, to furnish copy of this resolution each to the Secretary of Interior, Manila; to the Director of Public Works, Manila; to the Secretary of Finance, Manila; to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City; and to the City Engineer, Ormoc City.
