RESOLUTION NO. 191

WHEREAS, His Honor, the City Mayor, Ormoc City has informed the Honorable Body that our request for hospital aid in the amount of ₱20,000.00 was referred by the Honorable Secretary of Health, Manila to the Board of Director Philippine Charity Sweepstakes, Manila requesting favorable consideration;

BE IT KNOWN that out of the total sum of ₱10,000.00 allowed to Ormoc City by the Philippine Charity Sweepstakes, ₱1,000.00 was appropriated for the purchase of Hospital Site and/or the sub-division and fencing of the same, thus leaving a balance generous enough to start with the construction of hospital building, after deducting the sum of ₱1,500.00 per Resolution No. 44, c.s.

WHEREFORE,

The Board, on motion of Councilor Pablo S. Pajaron, seconded by Councilor Flaviano Montesclaros,

BE IT RESOLVED, as is hereby resolved to respectfully request the City Engineer, Ormoc City to relocate said hospital site and the fencing of the same as money ~~has~~ already appropriated for the purpose per Resolution No. 37 c.s.

RESOLVED FURTHERMORE, to request the City Engineer, Ormoc City to prepare the plan, specifications and estimated cost of construction of the proposed hospital building, and if the same is already prepared that it be submitted to the Municipal Board for its consideration to authorize its construction.

RESOLVED FINALLY, to furnish copy of this resolution each to the Honorable Secretary of Health Manila; to the Board of Director, Philippine Charity Sweepstakes, Manila, to the Director of Public Works, Manila; to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City, to the City Auditor, Ormoc City; to the City Engineer, Ormoc City; and to the City Health Officer, Ormoc City.
