WHEREAS, the City Supervisor of Orosi City, Mr. Felix de Veyra on 7th Indorsement dated December 21, 1950 hereto attached strongly recommended to the Municipal Board, Orosi City that the amount of P13,440.00 covering salary for one year of the seven principals already paid from funds of the National Government be resubmitted pending inclusion of such positions in the National plantilla;

WHEREAS, the City Supervisor aforementioned on 1st Indorsement dated September 1, 1950 hereto attached and other pertinent basic communication has strongly appealed to the Division Superintendent, Tacloban, Leyte that the seven (7) positions for principals be borne by the National Government by shifting 7 national primary positions allotted to the City of Orosi to take care of the 7 positions of principals for the seasons therein stated;

Therefore, The Board, on motion of Councilor Victorino C. Teloron, seconded by Councilor Pablo S. Pajaron;

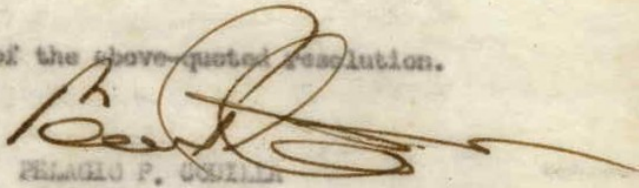
