WHEREAS, Vice Mayor, Marcelo D. Bandalan verbally informed the Honorable Body that upon verification in the Office of the Engineering Department of Ormoc City, he found out that there is still a balance of around Five Thousand (P5,000.00) Pesos out of Eight Thousand (P8,000) Pesos appropriated for the continuation of Bonifacio St;

WHEREAS, altho the construction of the continuation of said street is not yet finally completed, Vice Mayor Bandalan strongly supported the suggestion of Ex-Councillor Rafael D. Omega to extend San Joaquin, San Vidal and San Jorge Sts. so as to meet the extension of Bonifacio St. which extension work is to be taken from the balance of whatever amt. appropriated for the continuation of the construction of Bonifacio St.

WHEREFORE,

The Board, on motion of Vice Mayor Marcelo D. Bandalan, seconded by Councillor Cleto P. Evangelista;

BE IT RESOLVED, as is hereby resolved, to extend San Joaquin, San Vidal and San Jorge Sts. at Cantube District towards Bonifacio St. extension as suggested by Ex-Councillor Rafael D. Omega;

RESOLVED FURTHER, that in carrying out the work for the extension of said San Joaquin, San Vidal and San Jorge Sts. towards Bonifacio St. Extension, so much amount should be appropriated from whatever balance is left from the sum appropriated for the extension of Bonifacio St.;

RESOLVED FURTHERMORE, to provide the future funds sufficient to be appropriated to carry out the aforementioned project should the money appropriated for Bonifacio St. extension be not sufficient, after the City Engineer, Ormoc City has made the necessary estimate for the Construction of San Joaquin, San Vidal and San Jorge Sts. Extension aforementioned;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City and to the City Engineer, Ormoc City.
