RESOLUTION NO. 3

WHEREAS, on manifestation of Vice Mayor, Marcelo D. Bandalan, in his conversation with the City Engineer of Ormoc City in connection with the repair of Artesian Wells, said Vice Mayor informed the Honorable Body that the estimate of the City Engineer for the repair of artesian well, is \$200.00 for each artesian well.

WHEREAS, in connection with the subject, repair or cleaning of artesian wells, the second indorsement dated December 29, 1950 of Mr. C. J. Ventura, Chief Mechanic-Elec. Engineer of the Bureau of Public Works and the 3rd indorsement dated January 11, 1951 of the City Engineer of Ormoc City are hereunder quoted verbatim, respectively, as follows:

Respectfully returned to the City Engineer, Ormoc City, inviting attention to the self-explanatory provisions of Section XV-7, page 181 of B.P.W. Manual, and which is quoted hereunder:

"Subject: REPAIR OR CLEANING OF ARTESIAN  
WELLS

City(District) engineers shall not order the repair or cleaning of artesian wells without prior authority from this Bureau. Such work will only be executed upon formal request by resolution of the city(municipal) council concerned supported by a certificate of funds of the city (municipal) treasurer x x x x x."

It is informed in this connection, that the funds

provided under Republic Acts Nos. 88 and 143 have long been exhausted and pursuant to existing regulations, the repair of public artesian wells is under the direct supervision of the district and / or city engineers with funds to be made available by the municipal and/ or city councils where the artesian wells are located.

The Board, on motion of Vice Mayor, Marcelo D. Bandalan seconded by Councilor Felipe Adolfo;



FINALLY RESOLVED, to furnish copy of this resolution each to the Director of Public Works, Manila; to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City and to the City Engineer, Ormoc City.
