RESOLUTION NO. 4

WHEREAS, on manifestation of Councilor Pablo S. BE IT RESOLVED, as it is hereby resolved, to amend the time of holding the regular session of the Board that instead of 9 o'clock in the morning to 4 o'clock in the afternoon, hereafter, all regular session of the Municipal Board of this city be held from 4 o'clock in the afternoon to 8 o'clock in the evening extending said session after 8 o'clock in the evening as circumstances may require;

RESOLVED FURTHER, to amend, as it is hereby amended the internal rules and regulation of the Municipal Board of this city in so far as the above modification are concerned, thus revoking the standing internal rules aforementioned.

RESOLVED FINALLY, to furnish copy of this resolution to each and every councilor of the city.
