AS, the City Mayor finally, requested the investisting body to hold in aveyance the hearing against the se of the four policemen (in uniform) affected because he lieves that there is another person who is directly resconsible;

WHEREFORE;

The Board, on motion of Vice-Mayor Marcelo D. Bandalan, seconded by Councilor Felipe "dolfo;

BE IT RESOLVED, as is hereby resolved to dismisse the case against Felix Eamiguel, Felix Guillermer and Jose Esmero as recommended by the City Mayor on the ground aforementioned;

RESOLVED FURTHER, that the three secret servicemen aforementioned be reinstated at once with right to receive their corresponding salaries during the time of their suspension.

RESOLVED FURTHERMORE, to hold in abeyance the investigation of the four policemen in uniform, namely Pascasio Sungahid, Exaquil Mañago, Agapito Payod and Marcelino Laguna for further reinvestigation of the case against them;

RINALLY RESOLVED, to furnish copy of this resolution each to the City Tayor, OrmocCity; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City; to the Chief of Police, Ormoc City and to teach em every member of the secret servemen and four members of the Police Force in uniform, Ormoc City for their information and guidance. CARRIED UNANIMOUSLY.
